Freedom of Information Policy February 2014 Review

Publication Scheme on information available under the
Freedom of Information Act 2000
The governing body is responsible for maintenance of this scheme.

Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available for you on our website and in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

The School Aims:

To provide an educational environment appropriate for all children from 4 years to 7 years to learn, work co-operatively and have equal opportunity to develop their potential intellectually, physically, socially, emotionally and creatively.

To encourage self discipline and care and concern for others.

To provide a happy and purposeful community where all children and adults are valued.

To provide a place where all have equal opportunities regardless of culture, gender and social background.



To encourage all children to reach their academic potential by improving their progress through rigorous monitoring, formative assessment and high expectations.

Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Information - information published on school website.

Pupils & Curriculum - information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.

Maintained schools, academies and free schools are required to publish information on:

- Pupil premium allocation, use and impact on attainment
- Curriculum provision, content and approach
- Admission arrangements
- The school's policy in relation to behaviour, charging, and Special Educational Needs (SEN) and disability provision
- Links to Ofsted reports and to the Department for Education's (DfE's) achievement and attainment performance data
- The school's ethos and values
